# 1. Opening

The President of EMN opens the EMN aisbl General Assembly on 3rd October 2018 at 17h10.

The President observes at the beginning of the meeting that 60 members are either present or have nominated a proxy to vote on their behalf, which implies that 53% of the members are present. The quorum, which requires 33% of the members present as defined in our by-laws, is reached. 9 further members join the meeting after it being started for a total of 69 members.

# 4. Update on EMN membership
